

SEARCH FOR NOTICE OF COMMENCEMENT OF PATERNITY PROCEEDINGS

GENERAL INFORMATION

This search of Registry for Notice of Commencement of Paternity Proceedings is for ADOPTION use only. Utah and most courts accept this search in place of the birth certificate.

This search is not used for guardianship or any other court proceedings.

The purpose of the Registry for Notice of Commencement of Paternity Proceedings is to allow a father to provide notice they may be the father of a child possibly being placed for an adoption.

This registry does not establish paternity nor add the man's name to the birth certificate.

Certificates may be ordered online at vitalrecords.utah.gov.

Please read this application carefully. It is a criminal violation to make false statements on this application or to fraudulently obtain a vital records certificate.

All fees paid are non-refundable. If required information is missing from this application, applicant will have 90 days to provide missing information.
