A new birth certificate may only be issued once the adoption is finalized. (Utah Code 26B-8-125)  
Utah Vital Records may only issue certificates for births that occurred in Utah or a court-ordered delayed foreign birth filed in a Utah court. Certificates may be ordered online at [vitalrecords.utah.gov](http://vitalrecords.utah.gov). Read the application carefully. There are specific instructions for adoptions. The certificate fee is \$40, and there is a \$22 search fee. Additional copies of the certificate ordered at the same time are \$10 each. All fees paid are non-refundable. If required information is missing from this application, you have 90 days to provide the missing information before your request will be closed with no refund.

Please provide the requested information in the form below so DHHS Vital Records can process your request. The information you give us will only be used by DHHS to process your request, and if necessary, may be accessed by contractors who are a part of the DHHS technical team. All fields are required. We will not be able to process your request without the requested information. This data is part of the record series 81443.

# Acceptable identification to obtain vital records

## Identification (ID) must be current

Identification is required for all non-public vital records. Mailed requests must include an easily identifiable photocopy of the front and back of the identification from the list below or the application will be returned. One form of identification from the “Primary” column is required **or** two forms of identification from the “Secondary” column.

### Primary

(Need 1 – photo ID)

- Government issued photo driver’s license
- Government issued photo identification
- Employment authorization card
- U.S. military identification card
- Tribal identification card
- Permanent resident card
- Foreign visa
- U.S. passport
- U.S. passport card
- Foreign passport
- U.S. naturalization certificate or certificate of citizenship
- Matricula consular card
- Concealed weapon permit
- Mexican voter registration card
- Jail/prison release form (with picture)
- Veteran’s health ID card

### Secondary

(Need 2)

- Work identification - paycheck stub or W-2
- School, university or college ID card
- Voter registration card
- Social Security card
- U.S. military separation/DD-214
- Motor vehicle registration/title
- Marriage license (certified copy with signatures, not an abstract)
- Court order or court documents
- Jail/prison documents
- Probation documents
- Property tax receipt
- Selective Service card
- Hunting/fishing license
- Insurance card or documents
- Utility bill
- Business license
- Professional license

## We cannot accept:

- Novelty Identification Card (ID not issued by the government)
- Driving Privilege Card (prohibited by law UCA 53-3-207(7)(b)(ii)).

If you do not have acceptable identification, you can ask your spouse, parent, grandparent, sibling, or adult child to show their appropriate identification to request the certificate. You may be asked to show proof that you are related.
