The search fee for one certified copy of a stillbirth certificate is \$18. Additional copies ordered at the same time are \$10 each. All fees paid are non-refundable. If required information is missing from this application, you have 90 days to provide the missing information before your request will be closed with no refund.

The information you give us will only be used by DHHS to process your request, and if necessary, may also be accessed by contractors who are a part of the DHHS technical team. Acceptable identification to obtain vital records

Identification (ID) must be current

Identification is required for all non-public vital records. Mailed requests must include an easily identifiable photocopy of the front and back of the identification from the list below or the application will be returned. One form of identification from the “Primary” column is required or two forms of identification from the “Secondary” column.

We cannot accept:

- Novelty Identification Card (ID not issued by the government)
- Driving Privilege Card (prohibited by law UCA 53-3-207(7)(b)(ii)).

If you do not have acceptable identification, you can ask your spouse, parent, grandparent, sibling, or adult child to show their appropriate identification to request the certificate. Proof of relationship is required.
